Sloped entries must extend to depth of 24 inches minimum to 30 inches maximum below stationary water level to ensure buoyancy. At least one landing must be located 24 inches to 30 inches maximum below stationary water level. In wading pools, sloped entry and landings must extend to deepest part of pool.

Title III of the ADA requires that places of public accommodation (e.g., hotels, resorts, swim clubs, and sites of events open to the public) remove physical barriers in existing pools to the extent that it is readily achievable to do so (i.e., easily accomplishable and able to be carried out without much difficulty or expense).

ADA Requirements: Accessible Pools Means of Entry and Exit

ADA guidelines provide the specification of certain accessible elements in the design of new and renovated facilities to ensure that individuals with disabilities are generally able to access swimming pools and spas and use a variety of features of the facility.

ADA Summary Guidelines for Swimming Pools, Wading Pools ...

Access requirements differ depending on the size of the swimming pool. For large pools with over 300 linear feet of pool wall, two means of access are required. One of these MUST be a primary access. For smaller pools with under 300 linear feet of pool wall, at least one means of access must be provided, and it MUST be primary.

In January 2012, the Department issued guidance titled “ADA 2010 Revised Requirements: Accessible Pools—Accessible Means of Entry and Exit” to assist entities covered by Title III of the ADA, such as hotels and motels, health clubs, recreation centers, public country clubs, and other businesses that have swimming pools, wading pools, and spas, in understanding how the new requirements apply to them.

Providing physical cues or guides (for example, lane lines in the water or chairs and tables on the deck) and visual cues (for example, tape on the decks, floors, or sidewalks) and signs to ensure that staff, patrons, and swimmers stay at least 6 feet apart from those they don't live with, both in and out of the water.

Considerations for Public Pools, Hot Tubs, and Water ...

Sloped entries shall extend to a depth of 24 inches (610 mm) minimum and 30 inches (760 mm) maximum below the stationary water level. Where landings are required by 405.7, at least one landing shall be located 24 inches (610 mm) minimum and 30 inches (760 mm) maximum below the stationary water level.

1009 Swimming Pools, Wading Pools, and Spas - ADA ...

The specific requirements that swimming pools, wading pools and spas must meet can be found in chapter 2, section 242 of the revised ADA guidelines. Run-out pools for waterslides are not covered by these new ADA regulations.

Americans With Disabilities Act (ADA)

Section 242 of the new ADA Standards for Accessible Design applies to swimming pools, wading pools, spas and provides as follows: 242.1 General. Swimming pools, wading pools and spas shall comply with 242. 242.2 Swimming Pools.

New ADA Pool Accessibility Mandates & the HOA - William ...

Check local ordinances and codes for safety requirements. Use non-slip materials on the pool deck, diving board and ladders. The steps of the pool ladder should be at least three inches wide, and the ladder should have handrails on both sides small enough for a child to grasp. There should be a ladder at both ends of the pool.

2010 ADA Standards for Accessible Design 1009 Swimming Pools, Wading Pools, and Spas 1009.1 General. Where provided, pool lifts, sloped entries, transfer walls, transfer systems, and pool stairs shall comply with 1009.

2010 ADA Standards for Accessible Design - The Pool Professor

242 and 1009 Swimming Pools, Wading Pools, and Spas Accessible Means of Entry to Pools. Section 242 of the 2010 Standards requires at least two accessible means of entry for larger pools (300 or more linear feet) and at least one accessible entry for smaller pools.
