Overpayments may be the result of oversight, misunderstanding, technical errors, redetermination, adjudication, appeals decisions, Reemployment Assistance Appeals Commission orders, court decisions or other mitigating circumstances. When the Florida Department of Economic Opportunity (DEO) determines an overpayment has occurred on a Reemployment Assistance claim, a Notice of Determination will be distributed.

To request a tax refund, file an Application for Refund - Sales and Use Tax (Form DR-265) or Application for Refund - All Other Taxes (Form DR-26). An application form may be completed to request moneys paid into the State Treasury for a tax overpayment, payment when tax was not due, or payment made in error.
